Personal data that we process:

The Foundation Adoptiongraves Nederweert War Cemetery processes your personal data because you use our services and / or because you provide these to us yourself. Below you will find an overview of the personal data that we process:

- First and last name
- Address data
- Sex
- Phone number
- E-mail address
- Invoice and payment details

Special and / or sensitive personal data that we process:

Our website and / or service does not intend to collect data about website visitors under the age of 16. Unless they have permission from parents or guardian. However, we cannot check whether a visitor is older than 16. We therefore advise parents to be involved in the online activities of their children, to prevent data about children being collected without parental consent. For what purpose and on what basis do we process personal data:

processes your personal data for the following purposes:

- Foundation Adoptiongraves Nederweert War Cemetery does not store your personal data for longer than is strictly necessary.
  
- Foundation Adoptiongraves Nederweert War Cemetery does not provide data to third parties.
  
- Foundation Adoptiongraves Nederweert War Cemetery does not use cookies or similar techniques.
  
- You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw your consent for data processing or to object to the processing of your personal data by Foundation Adoptiongraves Nederweert War Cemetery and you have the right to data transferability. This means that you can submit a request to us to send the personal data that we hold about you in a computer file to you or another organization mentioned by you. You can send a request for access, correction, deletion, data transfer of your personal data or request for withdrawal of your consent or objection to the processing of your personal data to [adoptiegravennederweert@gmail.com](mailto:adoptiegravennederweert@gmail.com) .

To ensure that the request for inspection has been made by you, we request that you send a copy of your proof of identity with the request. Make in this copy your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and Citizen service number (BSN) black. This is to protect your privacy. We will respond to your request as quickly as possible, but within four weeks.
